ORDER :

In the G.O. 2nd read above, Govt. have identified "Khammam" as one of the places for establishment of Dental College in Private Sector.

2. The Director of Medical Education, Hyderabad who is the Member-convenor of Justice S.V.Maruthi Committee has issued a notification inviting applications for grant of Essentiality Certificate for establishment of Dental College at "Khammam" along with other places.

3. In pursuance of the above notification, M/s. Mamatha Educational Society, Khammam and others have applied to Justice S.V.Maruthi Committee for grant of Essentiality Certificate for establishment of Dental College at Khammam. Justice S.V.Maruthi Committee have inspected the proposed Dental College at Khammam and recommended for grant of Essentiality Certificate to M/s. Mamatha Educational Society, Khammam for establishment of Dental College at Khammam with 60 (sixty) BDS admissions per academic year.

4. The Govt. after careful examination of the above matter hereby issue Essentiality Certificate to M/s. Mamatha Educational Society for establishment of Dental College at Khammam with an admission capacity of 60 (sixty) students in BDS course per academic year, subject to the following conditions namely :-

- 1) that M/s. Mamatha Educational Society, Khammam should abide by the Dentists Act, 1948 as amended from time to time and the regulations framed thereunder for establishment of new Dental College;
- 2) that before applying for permission to establish the new Dental College M/s. Mamatha Educational Society, Khammam, shall ensure that the conditions laid down in the scheme relating to Dental Colleges referred to in clause (a) and (b) of Sub-Section (2) of Section 10-A of the Dentists Act, 1948, as amended from time to time as annexed to Regulations-2 of the Regulations relating to establishment of new Dental Colleges made by the Dental Council of India.

- 3) if ultimately, the Govt. of India / Dental Council of India grant permission for establishment of new Dental College by the said Society, the admission of students into the college and the fee structure should be in accordance with the rules and regulations or any executive orders issued or to be issued by the State or Central Governments or Dental Council of India or University of Health Sciences from time to time.

ORDER:


In G.O. 2nd read above, Government have granted Essentiality Certificate to M/s. Mamatha Educational Society, Khammam for establishment of a Dental College at Khammam with an intake capacity of 60 students per academic year.

2. In the representation 3rd read above, M/s. Mamatha Educational Society, Khammam have represented that they have sufficient infrastructural facilities for 100 admissions. They have also requested the Govt. to grant Essentiality Certificate for enhancement of seats from 60 to 100 in their Dental College at Khammam.

3. In the letter 4th read above, the Director of Medical Education has reported that Justice S.V.Maruthi Committee which was constituted for the purpose have inspected the Mamatha Dental College, Khammam on 19.06.2001 and recommended for grant of Essentiality Certificate for enhancement of BDS seats from 60 to 100 per academic year in Mamatha Dental College, Khammam to be established by M/s. Mamatha Educational Society, Khammam.

4. Government after careful examination of the matter hereby issue Essentiality Certificate to M/s. Mamatha Educational Society, Khammam for enhancement of BDS seats from 60 to 100 per academic year in their Dental College at Khammam subject to the following conditions :-

1. that M/s. Mamatha Educational Society, Khammam should abide by the Dentists Act, 1948 as amended from time to time and the regulations framed there under for enhancement of seats;
2. that before applying for permission for enhancement of seats in BDS course from 60 to 100, M/s. Mamatha Educational Society, Khammam shall ensure that the conditions laid down by Dental Council of India from time to time are fulfilled.
3. if ultimately, the Government of India / Dental Council of India grant permission for enhancement of seats by the said Society, the admission of students into the college and the fee structure should be in accordance with the rules and regulations or any executive orders issued or to be issued by the State or Central Governments or Dental Council of India or University of Health Sciences from time to time.
4. that the Essentiality Certificate now granted shall be valid for a period of (2) years and the management of the society should complete all required facilities for enhancement of seats from 60 to 100 within a period of two years from the date of issue of Essentiality Certificate. If the management fails to complete required facilities to enhance the seats within the validity period of Essentiality




